## Not for Profit Status-led by Johanna

The garden has two choices to obtain a not for profit status. First choice is to become an independent 501-c3 organization. This option would require annual filing fees & serious penalties if we did not renew. The second choice, which Johanna suggests, is to obtain fiscal sponsorship through the Open Space Institute (OSI). Becoming fiscally sponsored gives the Farm the ability to offer tax deductions for dues & donations, to make tax free purchases and be eligible for larger grants. OSI would sponsor our bank account for a fee of 8% of the deposits & in return we must abide by their requirements, provide them an annual financial report and display their logo on our website.

Concern was expressed in the lack of information presented/known about OSI. One member suggested they could be terrorists. Other questions included: who is OSI & how long have they existed? do we have to have a fundraising party for OSI? (no); what grants would we apply for? (purchasing plants for community tree wells). Johanna will bring more information to the April meeting and offers that we could speak with other Gardens to hear their experiences with OSI. Applications for fiscal sponsorship are considered quarterly.

## One Year Box Loan Policy

In the effort to maximize planting opportunities for garden Members, if a Box Holder knows they cannot cultivate their box for a season (e.g. due to planned surgery, care for a sick family member, etc.) that member may loan their box for **one** planting season. The additional responsibilities that go with box gardening are also transferred with the right to garden the box and the lending member's responsibilities will be that of a general member for the season.

The box will be offered to the next person on the waiting list with the understanding that its use is temporary and for one planting season only. The 'renter' will not lose their place on the Box Waiting List until they are permanently assigned a box.

The following season the Box Holder may resume cultivating the box. If the Holder does not return the following year, their box will be considered abandoned and will be offered first to the other Box Holders if they wish to switch planting locations. (The 'renter' will be assigned the next available box accordingly to their position on the Waiting List.)

Before any arrangements are made All Box Holders must coordinate with the Box Coordinator if they wish to loan their box for a year or if they desire to move.
